Effective June 1, 2017, the 3.25% per hour increase will be allocated to increase Health  
and Welfare contributions by fifty cents (\$0.50) per hour, the Pension contribution by  
twenty-five cents (\$0.25) per hour and wages by the following amounts:

Group 1 will increase by one dollar and .067 cents (\$1.067) per hour  
Group 2 will increase by one dollar and .075 cents (\$1.075) per hour  
Group 3 will increase by one dollar and .082 cents (\$1.082) per hour  
Group 4 will increase by one dollar and .089 cents (\$1.089) per hour

June 1, 2017:
